Dr Steven Sadowsky is professor and director of implant education at the University of the Pacific Arthur A. Dugoni School of Dentistry. He was in full-time private practice limited to prosthodontics for 35 years. Dr Sadowsky is past president of the American Prosthodontic Society and president-elect of the Pacific Coast Society for Prosthodontics, as well as fellow of the Academy of Prosthodontics and the American College of Prosthodontics. He has directed the American College of Prosthodontics Annual Review Course for the last 5 years. In 1987 he became a diplomate of the American Board of Prosthodontists and has been invited to sit on the editorial review boards of The Journal of Prosthetic Dentistry, the International Journal of Oral and Maxillofacial Implants, and the International Journal of Prosthodontics. Dr Sadowsky has published 20 articles in peer-reviewed journals and contributed chapters in books, mainly on the topic of implant dentistry. He has edited a book titled, *Evidence-based Implant Treatment Planning and Clinical Protocols* which will be published by the end of the year. Dr Sadowsky is the 2016 recipient of the American College of Prosthodontists Presidential Citation for meritorious service to prosthodontics.
